It is TPI'S duty and pleasure to provide all information needed and ensure that the traveler understands the conditions of this contract. *Responsibilities:* TPI, its affiliated entities and its employees, shareholders, officers, directors, successors, agents, and assigns (collectively "TRAVEL PROFESSIONALS INTERNATIONAL"), does not own or operate any person or third-party entity which is to or does provide goods or services for these trips. Because TPI does not maintain any control over the personnel, equipment, or operations of these third-party suppliers, TPI assumes no responsibility for and cannot be held liable for any personal injury, death, property damage or other loss, accident, delay, inconvenience, or irregularity which may be occasioned by reason of (1) any wrongful, negligent, willful or unauthorized acts or omissions on the part of any of the suppliers or other employees or agents, (2) any defect in or failure of any vehicle, equipment, or instrument owned, operated or otherwise used by any of these suppliers, or (3) any wrongful, willful or negligent act or omission on the part of any other party not under the supervision and control of TPI. Additionally, responsibility is not accepted for losses or expenses due to sickness, lack of appropriate medical facilities or practitioners, weather, strikes, theft or other criminal acts, war, terrorism, computer problems, or other such causes. All services and accommodations are subject to the laws of the country in which they are provided. TPI, reserves the right to make changes in the published itinerary and rates whenever, in its sole judgment, conditions warrant, or if they deem it necessary for the comfort, convenience, or safety of the tour. TPI reserves the right to withdraw any tour announced. TPI reserves the right to decline to accept any person as a member of the tour, or to require any participant to withdraw from the tour at any time, when such action is determined by the tour manager to be in the best interests of the health, safety, and general welfare of the tour group or of the individual participant. TPI does not accept liability for any carrier's /supplier's cancellation penalty incurred by the purchase of a non-refundable airline or other ticket(s) to the tour departure city and return or otherwise. Baggage and personal effects are the sole responsibility of the owner at all times. *Arbitration* - I (the client) agree that any dispute concerning, relating, or referring to this contract, the brochure or any other literature concerning my trip, or the trip itself, shall be resolved exclusively by binding arbitration according to the then existing rules of the province of Ontario, Canada. Such proceedings will be governed by substantive Ontario law.

CANCELLATION FEES:

Once full payment has been made, it is 100% non refundable.

Land Travel: The land is provided by Yvonne Mulder and Shamrock Lodge. No refunds will be made for any unused portion including hotels, sightseeing, cruises, transfers, meals, international or domestic flight with or without notice, unless cancelled or missed by the supplier.

Accommodation: Room-service, in-room movies and snacks, as well as telephone charges, must be paid for by the user. Damage done to public or private property while on the tour will be the responsibility of the person who causes the damage. All hotels have been carefully chosen to provide a standard of excellence and cleanliness.

Baggage handling/size: Luggage size must not exceed 28"x 20"x 9" and hand baggage must not exceed 13" x 19", in order to fit in compartments. One piece of each size per person is allowed. You must be able to take your own luggage from the bus to your room, in case there is no porter service available.

Motor coach info: You will be traveling by motor coach transportation that is climate controlled, offers reclining seats, washroom facilities, stereo music and more. ***Please note that a rotating rule will be put in effect for this tour. This means that we are going to ask everyone to rotate seats regularly. If you are prone to motion sickness, I ask that you take gravol or consider other remedies that are available for motion sickness. This will help give everyone a chance to sit at the front of the bus at some point during our travel. I ask that you please pay close attention to where you need to move to each time so that you do not disrupt the change of seats. I thank you in advance for respecting this request and where there are special circumstances or extreme motion sickness issues, we will make changes to meet your needs. What to bring: We recommend that you bring a warm jacket and/or a rain repellent jacket, a compact umbrella, camera, film, binoculars, good walking shoes.

Conditions of travel: Please understand that all passengers who participate with this bus tour must operate independently, and if not must be accompanied by a qualified assistant. Some walking will be required for most of the tours. Smoking will not be permitted on the motor coach. TPI reserves the right to terminate the trip of any member whose conduct is incompatible with the well-being of other passengers. No refunds will be given in such cases and the return fare will be at the expense of the person in question.

Insurance: It is highly recommended that participants buy cancellation insurance to cover the non-refundable cost of this tour.

Tour cancellation by operator: If, in the opinion of the tour leader, and conditions warrant it, TPI reserves the right to cancel the tour at any time, up to departure, and will have no responsibility beyond refunding the fare paid by each customer, less any non-refundable reservation expenses incurred.
